



Human Resources Outsourcing

AMN Healthcare Services, Inc. (NYSE:AMN) reported second quarter net income of \$66.8 million for fiscal year 2021 as compared to \$22.3 million for the prior year period. Earnings per share were \$1.39 versus \$0.47 for the prior year period. Revenues for the quarter increased to \$857.4 million from \$608.4 million for the same period in fiscal year 2020.

Cross Country Healthcare, Inc. (NasdaqGS:CCRN) reported third quarter net income of \$23.4 million for fiscal year 2021 as compared to (\$1.3) million for the prior year period. Earnings per share were \$0.62 versus (\$0.04) for the prior year period. Revenues for the quarter increased to \$374.9 million from \$194.0 million for the same period in fiscal year 2020.



Selected News Fixed Asset Management

Comfort Systems USA, Inc. (NYSE:FIX) reported third quarter net income of \$46.3 million for fiscal year 2021 as compared to \$50.1 million for the prior year period. Earnings per share were \$1.27 versus \$1.36 for the prior year period. Revenues for the quarter increased to \$833.9 million from \$714.1 million for the same period in fiscal year 2020.

EMCOR Group, Inc. (NYSE:EME) reported third quarter net income of \$99.7 million for fiscal year 2021 as compared to \$61.2 million for the prior year period. Earnings per share were \$1.85 versus \$1.11 for the prior year period. Revenues for the quarter increased to \$2,521.7 million from \$2,201.7 million for the same period in fiscal year 2020.

Healthcare Services Group, Inc. (NasdaqGS:HCSG) reported third quarter net income of \$9.5 million for fiscal year 2021 as compared to \$27.6 million for the prior year period. Earnings per share were \$0.13 versus \$0.37 for the prior year period. Revenues for the quarter decreased to \$415.6 million from \$435.9 million for the same period in fiscal year 2020.

Heritage-Crystal Clean, Inc (NasdaqGS:HCCI) reported third quarter net income of \$18.5 million for fiscal year 2022 as compared to \$4.0 million for the prior year period. Earnings per share were \$0.79 versus \$0.17 for the prior year period. Revenues for the quarter increased to \$123.2 million from \$87.1 million for the same period in fiscal year 2021.




