

Human Resources Outsourcing

AMN Healthcare Services, Inc. (NYSE:AMN) reported third quarter net income of \$74.0 million for fiscal year 2021 as compared to \$26.1 million for the prior year period. Earnings per share were \$1.54 versus \$0.55 for the prior year period. Revenues for the quarter increased to \$877.8 million from \$551.6 million for the same period in fiscal year 2020.

Barrett Business Services, Inc. (NasdaqGS:BBSI) reported third quarter net income of \$14.9 million for fiscal year 2021 as compared to \$18.5 million for the prior year period. Earnings per share were \$1.96 versus \$2.40 for the prior year period. Revenues for the quarter increased to \$247.0 million from \$227.5 million for the same period in fiscal year 2020.

Computer Task Group, Incorporated (NasdaqGS:CTG) reported third quarter net income of \$1.7 million for fiscal year 2021 as compared to \$2.8 million for the prior year period. Earnings per share were \$0.11 versus \$0.20 for the prior year period. Revenues for the quarter increased to \$90.6 million from \$88.6 million for the same period in fiscal year 2020.

CRA International, Inc. (NasdaqGS:CRAI) reported third quarter net income of \$10.9 million for fiscal year 2022 as compared to \$5.4 million for the prior year period. Earnings per share were \$1.44 versus \$0.68 for the prior year period. Revenues for the quarter increased to \$136.4 million from \$121.8 million for the same period in fiscal year 2021.

Cross Country Healthcare, Inc. (NasdaqGS:CCRN) reported third quarter net income of \$23.4 million for fiscal year 2021 as compared to (\$1.3) million for the prior year period. Earnings per share were \$0.62 versus (\$0.04) for the prior year period. Revenues for the quarter increased to \$374.9 million from \$194.0 million for the same period in fiscal year 2020.

Fair Isaac Corporation (NYSE:FICO) reported net income of \$392.1 million for fiscal year 2021 as compared to \$236.4 million for the prior year. Earnings per share were \$13.40 versus \$7.90 for the prior year. Revenues for the year increased to \$1,316.5 million from \$1,294.6 million for fiscal year 2020.

Hudson Global, Inc. (NasdaqGS:HSON) reported third quarter net income of \$1.5 million for fiscal year 2021 as compared to (\$1.2) million for the prior year period. Earnings per share were \$0.49 versus (\$0.41) for the prior year period. Revenues for the quarter increased to \$45.0 million from \$25.4 million for the same period in fiscal year 2020.

Huron Consulting Group Inc. (NasdaqGS:HURN) reported third quarter net income of \$13.7 million for fiscal year 2021 as compared to \$11.1 million for the prior year period. Earnings per share were \$0.64 versus \$0.50 for the prior year period. Revenues for the quarter increased to \$224.0 million from \$205.3 million for the same period in fiscal year 2020.

Insperity, Inc. (NYSE:NSP) reported third quarter net income of \$27.3 million for fiscal year 2021 as compared to \$20.0 million for the prior year period. Earnings per share were \$0.70 versus \$0.51 for the prior year period. Revenues for the quarter increased to \$1,209.6 million from \$1,007.8 million for the same period in fiscal year 2020.

Kelly Services, Inc. (NasdaqGS:KELY.A) reported third quarter net income of \$34.8 million for fiscal year 2022 as compared to \$16.7 million for the prior year period. Earnings per share were \$0.87 versus \$0.42 for the prior year period. Revenues for the quarter increased to \$1,195.4 million from \$1,038.2 million for the same period in fiscal year 2021.

Kforce Inc. (NasdaqGS:KFRC) reported third quarter net income of \$20.2 million for fiscal year 2021 as compared to \$18.8 million for the prior year period. Earnings per share were \$0.96 versus \$0.89 for the prior year period. Revenues for the quarter increased to \$402.7 million from \$365.4 million for the same period in fiscal year 2020.

RCM Technologies, Inc. (NasdaqGM:RCMT) reported third quarter net income of \$2.8 million for fiscal year 2022 as compared to (\$0.2) million for the prior year period. Earnings per share were \$0.24 versus (\$0.02) for the prior year period. Revenues for the quarter increased to \$45.5 million from \$31.6 million for the same period in fiscal year 2021.






