

CBIZ, Inc. (**NYSE:CBZ**) reported net income of \$70.9 million for fiscal year 2021 as compared to \$78.3 million for the prior year. Earnings per share were \$1.32 versus \$1.42 for the prior year. Revenues for the year increased to \$1,104.9 million from \$963.9 million for fiscal year 2020.

Computer Task Group, Incorporated (NasdaqGS:CTG) reported net income of \$13.7 million for fiscal year 2021 as compared to \$7.6 million for the prior year. Earnings per share were \$0.92 versus \$0.53 for the prior year. Revenues for the year increased to \$392.3 million from \$366.1 million for fiscal year 2020.

Exponent, Inc. (NasdaqGS:EXPO) reported net income of \$101.2 million for fiscal year 2021 as compared to \$82.6 million for the prior year. Earnings per share were \$1.90 versus \$1.55 for the prior year. Revenues for the year increased to \$434.9 million from \$378.4 million for fiscal year 2020.

FTI Consulting, Inc. (**NYSE:FCN**) reported net income of \$235.0 million for fiscal year 2021 as compared to \$210.7 million for the prior year. Earnings per share were \$6.65 versus \$5.67 for the prior year. Revenues for the year increased to \$2,776.2 million from \$2,461.3 million for fiscal year 2020.

Heidrick & Struggles International, Inc. (NasdaqGS:HSII) reported net income of \$72.6 million for fiscal year 2021 as compared to (\$37.7) million for the prior year. Earnings per share were \$3.58 versus (\$1.95) for the prior year. Revenues for the year increased to \$1,003.0 million from \$621.6 million for fiscal year 2020.

Huron Consulting Group Inc. (NasdaqGS:HURN) reported net income of \$63.0 million for fiscal year 2021 as compared to (\$23.8) million for the prior year. Earnings per share were \$2.89 versus (\$1.09) for the prior year. Revenues for the year increased to \$905.6 million from \$844.1 million for fiscal year 2020.

Insperity, Inc. (NYSE:NSP) reported net income of \$124.1 million for fiscal year 2021 as compared to \$138.2 million for the prior year. Earnings per share were \$3.18 versus \$3.54 for the prior year. Revenues for the year increased to \$4,973.1 million from \$4,287.0 million for fiscal year 2020.

Kelly Services, Inc. (NasdaqGS:KELY.A) reported net income of \$156.1 million for fiscal year 2022 as compared to (\$72.0) million for the prior year. Earnings per share were \$3.91 versus (\$1.83) for the prior year. Revenues for the year increased to \$4,909.7 million from \$4,516.0 million for fiscal year 2021.

Kforce Inc. (NasdaqGS:KFRC) reported net income of \$75.2 million for fiscal year 2021 as compared to \$56.0 million for the prior year. Earnings per share were \$3.54 versus \$2.62 for the prior year. Revenues for the year increased to \$1,579.9 million from \$1,397.7 million for fiscal year 2020.

ManpowerGroup Inc. (**NYSE:MAN**) reported net income of \$382.4 million for fiscal year 2021 as compared to \$23.8 million for the prior year. Earnings per share were \$6.91 versus \$0.41 for the prior year. Revenues for the year increased to \$20,724.4 million from \$18,001.0 million for fiscal year 2020.

TriNet Group, Inc. (NYSE:TNET) reported net income of \$338.0 million for fiscal year 2021 as compared to \$272.0 million for the prior year. 


