


Commentary

Economic activity in the manufacturing sector grew in June, with the overall economy achieving a 25th consecutive month of growth.

New Orders, Employment, Production, Backlog, Raw Materials Inventories, Prices and Exports and Imports all grew in June while Supplier Deliveries slowed at a reduced rate.

Unemployment Rate

Unemployment rate is traditionally defined as the percentage of the total labor force that is actively looking for gainful employment.





Commentary

Total nonfarm payroll employment rose by 372,000 in June, and the unemployment rate remained at 3.6 percent. The U.S. Bureau of Labor Statistics reported notable job gains in professional and business services, leisure and hospitality, and health care. Unemployment rate remains unchanged for the fourth month in a row, totaling 5.9 million unemployed persons in June 2022.

Industrial Production and Capacity Utilization

The Production Index (in red below) measures real output and is expressed as a percentage of real output in a base year, currently 2007. The Capacity Index (in green below), which is an estimate of sustainable potential output, is also expressed as a percentage of real output in 2007.

Commentary

Industrial production decreased by 0.2% in June, and Manufacturing output declined by 0.5% for a second consecutive month in June. At 104.4% of its 2017 average, industrial production in June was 4.2% above its year-earlier level. Capacity utilization decreased 0.3% in June to 80.0%, while remaining 0.4% above its long-run average.

 Index was revised May 28, 2021 to reflect 2017 as a base year (rather than 2012) and adopt 2017 NAICS groups.

Producer Price Index (PPI) & Consumer Price Index (CPI)

The PPI measures the average change over time in prices received (price changes) by producers for domestically produced goods, services and construction. The CPI measures changes in the prices paid by urban consumers for a representative basket of goods and services.

Commentary

CPI for all items rose by 1.3% in June, driven by increases in gasoline, shelter, and food. PPI for final demand rose by 1.1% in June, driven by a 2.4% increase in prices for final demand goods related to a 10.0% jump in energy prices. The index for final demand services increased by 0.4%.


Sector Index Performance


Comparative Sector Index Performance (Last Twelve Months)

Comparative Subsector LTM EV/Revenue



Commentary

Comparative Subsector LTM EV/EBTIDA



Comparative Subsector LTM Gross Margin



Comparative Subsector LTM EBITDA Margin




Index Subsector LTM EV/EBITDA vs. EBITDA Margin


Index Subsector LTM EV/EBITDA vs. Gross Margin



Textron Inc. (NYSE:TXT) acquired Pipistrel D.O.O. Ajdovscina, Pipistrel Vertical Solutions d.o.o and Pipistrel Italia S.r.l. on April 15, 2022. Pipistrel develops high technology in light aviation, unveiling concepts such as electric flight and pursuing extreme aero efficiency.

Textron Inc. acquired a 90% stake in the company for \$218 Million, this results in a total enterprise value of \$242.2 Million.






